PETITIONER'S NOTICE OF AMENDED FACTUAL ALLEGATION

Petitioner Palm Beach County Canvassing Board alleged in its Petition, filed yesterday, that it intended to "resume the recount on November 15, 2000, while seeking a judicial determination" of the issues presented. (Petition, p. 7). This morning, the Board voted again and changed its position, voting to suspend the manual recount pending this Court's decision. Because that is a substantial change in the factual statement presented in the Motion, we submit this Notice to keep the Court fully informed.

In addition, we supplement footnote 1 of the Petition with this information. The United States Court of Appeals for the Eleventh Circuit has a case pending, *Touchstone v. McDermott*, 11th Cir. No. 00-15985, which also presents the issue of whether the Palm Beach County manual recount should be enjoined. That Court has granted *en banc* consideration, requested responses to an Emergency Motion for Injunction Pending Appeal and to Expedite by 7:00 a.m. November 16, 2000,

and, it is reported, that an order scheduling a hearing date and time is forthcoming.
